



Warranty and End User License Agreement

Allpro Security Wireless House Alarm System

1. Warranty

1.1 Limited Warranty

Allpro Security warrants that the Allpro Security wireless house alarm system will be free from material defects in materials and workmanship under normal use for a period of one (1) year from the date of purchase (warranty period). This warranty is valid only for the original purchaser (Customer) and is non-transferable.

1.2 Exclusions

This warranty does not cover:

- Damage caused by misuse, abuse, or neglect.
- Alterations, modifications, or repairs performed by anyone not authorized by Allpro Security.
- Damage caused by external factors such as power surges, extreme weather, or acts of nature.
- Normal wear and tears, including cosmetic damage.

1.3 Remedies

During the Warranty Period, at Our sole discretion, we will repair or replace any defective Product or part at no charge. Replacements may include refurbished components. If the Product is no longer available, a similar product of equal value may be provided.

1.4 How to Claim Warranty Service

2. End User License Agreement (EULA)

The App and all associated intellectual property rights are owned by Allpro Security. This Agreement does not grant you any ownership rights.

2.4 Updates and Modifications

We may provide updates to the App. Such updates may include bug fixes, enhancements, or new features and are subject to the terms of this Agreement. Continued use of the App constitutes acceptance of updates.
